COVID-19 Safety Protocols for Big Sand Camps

1. Everyone participating will be required to sign and submit our *Volleyball Winnipeg-Informed Consent and Assumption of Risk Agreement* form on day one of the event.
2. Everyone entering the facility will be required to complete the *COVID-19 Screening Tool* and *COVID-19 Sign-In Sheet*.
 - a. Anyone who answers 'yes' to any of the screening questions will not be permitted to participate and will be asked to leave the event.
3. No spectators permitted in the facility.
4. Gym attendance will be limited to a maximum of 22 participants per court, including coaches.
5. Hand sanitizer is available at the entrance of the gym. All participants are required to make use of it.
6. No outside balls permitted.
 - a. Balls will be provided and sanitized after each group.
7. Facility staff may regulate the flow of traffic in their lobby should too many individuals remain in the lobby area.
 - a. In cases where there is room in the facility lobby for a few parents, social distancing must be respected.
 - i. Most parents will be asked not to stay in the lobby but return after the event is over.
8. Athletes must wait outside for permission to enter the building.
 - a. Permission will be granted by either a **Big Sand** coach or facility staff member
 - b. Entrance will be permitted once the previous group has vacated the gym and equipment has been wiped down.
9. No sharing or moving other players water bottles or other belongings.

1. This is a binding legal agreement. Clarify any questions or concerns before signing. Prior to participating, an individual who is younger than the age of majority and who wants to participate in the sport of volleyball and the activities, programs, classes and services provided by, and/or in the events sponsored or organized by Volleyball Winnipeg and BIG SAND Volleyball Club which may include but is not limited to: camps, competitions, practices, training, personal or strength training, dry land training, training using machines or weights, nutritional and dietary programs, orientational or instructional sessions or lessons, and aerobic and anaerobic conditioning programs (collectively the "Activities") must have their legal parent/guardian ("the Parties") acknowledge and agree to the terms outlined in this agreement.
2. The undersigned acknowledges and agrees they are a parent/guardian of the Participant and have full legal responsibility for the decisions of the Participant.

Disclaimer

3. We here by state that Big Sand Volleyball Club, and their respective Directors, Officers, committee members, members, employees, coaches, volunteers, officials, participants, agents, sponsors, owners/operators of the facilities in which the Activities take place, and representatives (collectively the "Organization") are not responsible for any injury, property damage, death, expense, loss of income, damage or loss of any kind suffered by the Participant during, or as a result of, the Activities.

We have read and agree to be bound by paragraphs 1 to 3

Description and Acknowledgement of Risks

4. The Parties understand and acknowledge that:
 - a) The Activities have foreseeable and unforeseeable inherent risks, hazards and dangers that no amount of care, caution or expertise can eliminate, including without limitation, the potential for serious bodily injury, permanent disability, paralysis and loss of life
 - b) The Organization may offer or promote online programming (such as webinars, remote conferences, workshops, and online training) which have different foreseeable and unforeseeable risks than in-person programming
 - c) The Organization has a difficult task to ensure safety and it is not infallible. the Organization may be unaware of the Participant's fitness level or abilities, may give incomplete warnings or instructions, may misjudge environmental conditions, and the equipment being used might malfunction
 - d) **(COVID-19)** The COVID-19 disease has been declared a worldwide pandemic by the World Health Organization and COVID-19 is extremely contagious. The Organization has put in place preventative measures to reduce the spread of COVID-19; however, the Organization cannot guarantee the Participant will not become infected with COVID-19. Further, participating in the Activities could increase the Participant's risk of contracting COVID-19
5. The Participant is participating voluntarily in the Activities. In consideration of that participation, the Parties hereby acknowledge they are aware of the risks, dangers and hazards and may be exposed to such risks, dangers and hazards. The Parties understand the Organization may fail to safeguard or protect the Participant from the risks, dangers and hazards of the Activities, some of which are listed below. The risks, dangers and hazards include, but are not limited to:
 - a) Health: executing strenuous and demanding physical activity; physical exertion; overexertion; stretching; dehydration; fatigue; cardiovascular workouts; rapid movements and stops; lack of fitness or conditioning; traumatic injury; sprains and fractures, spinal cord injuries, bacterial infections; rashes; and the transmission of communicable diseases, including viruses of all kinds, COVID-19, bacteria, parasites or other organisms or any mutation thereof
 - b) Premises: defective, dangerous or unsafe condition of the facilities; falls; collisions with objects, walls, equipment or persons; dangerous, unsafe, or irregular conditions on floors or other surfaces; and travel to and from the premises
 - c) Use of equipment: mechanical failure of the equipment; negligent design or manufacture of the equipment; the provision of or the failure by the Organization to provide any warnings, directions, instructions or guidance as to the use of the equipment; failure to wear safety or protective equipment; and failure to use or operate equipment within the Participant's own ability
 - d) Contact: contact with the ball; contact between athletes or with equipment; and other contact that may lead to serious bodily injury, including but not limited to concussions and/or other brain injury or serious spinal injury
 - e) Advice: negligent advice regarding the Activities
 - f) Ability: failing to act safely or within the Participant's own ability or within designated areas
 - g) Sport: the sport of volleyball has its inherent risks, including but not limited to, being hit by a ball or running into other participants or running into equipment, walls or other hazards
 - h) Cyber: privacy breaches; hacking; and technology malfunction or damage

- i) Conduct: the Participant's conduct, and that of other persons, including any physical altercation between participants
- j) Travel: travel to and from the Activities
- k) Negligence: the Participant's negligence, the Parties' negligence, and/or the negligence of other persons, including NEGLIGENCE ON THE PART OF THE ORGANIZATION, which may increase the risk of damage, loss, personal injury or death

We have read and agree to be bound by paragraphs 4 and 5

Terms

6. In consideration of the Organization allowing the Participant to participate in the Activities, the Parties agree:
- a) When the Participant practices or trains in their own space, the Parties are responsible for the Participant's surroundings and the location and equipment that is selected for the Participant
 - b) That the Participant's mental and physical condition is appropriate to participate in the Activities and the Parties assume all risks related to the Participant's mental and physical condition
 - c) To comply with the rules and regulations for participation in the Activities
 - d) To comply with the rules of the facility and the rules for the use of its equipment
 - e) If the Participant observes an unusual, significant hazard or risk, the Participant will remove themselves from participation and bring their observations to a representative of the Organization immediately
 - f) The risks associated with the Activities are increased when the Participant is impaired, and the Participant will not participate if impaired in any way
 - g) It is their sole responsibility to assess whether any Activities are too difficult for the Participant. By the Participant commencing an Activity, they acknowledge and accept the suitability and conditions of the Activity
 - h) They are responsible for the choice of the Participant's safety or protective equipment and the secure fitting of that equipment
 - i) **(COVID-19)** That COVID-19 is contagious in nature and the Participant may be exposed to, or infected by, COVID-19 and such exposure may result in personal injury, illness, permanent disability, or death
7. In consideration of the Organization allowing the Participant to participate, the Parties agree:
- a) That the Parties are not relying on any oral or written statements made by the Organization or their agents, whether in brochure or advertisement or in individual conversations, to agree to participate in the Activities
 - b) That the Organization is not responsible or liable for any damage to the Participant's vehicle, property, or equipment that may occur as a result of the Activities
 - c) That this Agreement is intended to be as broad and inclusive as is permitted by law within the Province of Manitoba and if any portion thereof is held invalid, the balance shall, notwithstanding, continue in full legal force and effect

Jurisdiction

8. The Parties agree that, in the event they file a lawsuit against the Organization, they agree to do so solely in the Province of Manitoba and they further agree that the substantive law of the Province of Manitoba will apply without regard to conflict of law rules.

Acknowledgement

9. The Parties acknowledge they have read this agreement and understand it; they have executed this agreement voluntarily; and this Agreement is to be binding upon themselves, their heirs, their spouses, guardians, next of kin, executors, administrators and legal or personal representatives.
